The Division II Administrative Committee met this afternoon and discussed the Division II Planning and Finance Committee's recommendation regarding reductions to the 2021 winter and spring championships brackets/field sizes. The committee also discussed a one-year waiver of regional site determination.

The committee approved a recommendation from the Division II Planning and Finance Committee and the Division II Championships Committee to reduce the brackets/field sizes of the 2021 winter and spring championships. The reductions reflect recommendations from the Division II winter and spring sport committees, which the Division II Championships Committee approved. These reductions determine appropriate brackets/field sizes that help mitigate projected budget shortfalls without compromising the student-athlete experience.

Most sport committees arrived at a 25% reduction. Instances where the recommended reductions are more or less than 25% are primarily due to logistical or practical concerns with operating the event. See below for the approved brackets/field sizes reductions.

The Division II governance structure, including sports committees and the Championships Committee, will continue to monitor and adapt to any possible changes due to the COVID-19 pandemic.

In addition to the approval by the Administrative Committee on brackets/field sizes reductions, the Championships Committee agreed that given the challenges inherent within the selection process this year with reduced competitions (particularly nonconference competitions), winter and spring sport committees and their regional advisory committees (RACs) will be allowed to use any or all of the selection criteria available to them, provided the criteria are applied consistently throughout the season. The availability of all criteria will start this winter for the men's and women's basketball committees and RACs for the selection of participants for the men's and women's basketball championships.

The committee also approved the Championships Committee's recommendation to provide a one-year waiver of regional site determination for the 2020-21 academic year only. This waiver provides sport committees flexibility in selecting regional hosts. Due to 2021 winter and spring championships moving to predetermined sites, this waiver provides the necessary flexibility to prepare for a scenario in which a top-seeded team is unable to host regional competition.

The committee received the Membership Committee's recommendation to delay the Institutional Self-Study Guide submission deadline for institutions in Class 1. Institutions in ISSG Class 1 will now be required to submit the ISSG by May 31, 2022. This relief does not apply to Provisional Year One institutions in the membership process.

The committee supported flexibility for prospective student-athletes who delay initial full-time collegiate enrollment and would be impacted by organized competition occurring in the 2020-21 academic year. A prospective student-athlete who has not previously enrolled full-time at a collegiate institution and whose legislated grace period concluded prior to or during the 2020-21 academic year may engage in organized competition during the 2020-21 academic year without using a season of competition.
